12 Month Contract - General Insects, including Cockroaches and Rodents:

The following maintenance treatment will be done at your property.

- Inspect, maintain and re-bait all effected areas on the property, strategically placing all bait out of sight.
- Pet and Human friendly residual spray on the inside perimeters of the property.
- NON Pet and Human friendly spray on the outside perimeters of the property.
- Monthly Pest Control Certificate for your records
- Updating all documentation with regards to your HACCP file

In the case that you have a big infestation, it is recommended to do a follow up treatment every 2 weeks, by means of a re-spray and bait of all effected areas after the initial treatment date, for a period minimum period of 3 months. This is in order to break the life cycle of the pest.

Your monthly treatment for your business will be at a cost of R990.00 per month.

Cost breakdown of this agreement:

The treatment at Thunder Ridge Spur, Rooihuiskraal Rd &, Basson Ave, Celtisdal, Centurion will be done each month at a cost of R990.00 per treatment.

Each treatment will be done 4 weeks or 1 month apart.

Therefore there will be a total of 12 treatments to be done in a 12 month period.
